# Indoor Youth 11v11 \& Small-Sided Soccer League Policies and Regulations 

(Updated November 2023)

## 1. Membership

a) Applications to play in the league must be received on a form provided by the League, by the deadline date specified on the approved League application form. League fees must be paid in accordance with the schedule for payments noted on the form and where applicable must also be accompanied by a copy of the approved Playing Out Rights received from their appropriate District Association.
b) Teams withdrawing from the league at any time will not receive a refund (whether before or after the season has started). Once a team has paid the deposit amount or full league fee, they agree to participate in the entire season, therefore not entitled to a refund.
i. Notwithstanding b) above, if the League is forced to suspend operations, refunds will be given for any part of the incomplete schedule, minus a small administration fee.
c) The League reserves the right to amend or balance the divisions based on the ability and number of teams who apply. This includes combining different age groups into one division.
d) The League reserves the right to approve or deny acceptance of a team's application to participate in the Downsview Soccer League.

## 2. Laws of the Game

The Downsview Soccer League (DSL) shall support and maintain the principles of the Laws of the Game as follows:

1) Small-Sided Soccer - as established by Ontario Soccer Indoor Rules, with the following exceptions:
a. In the Grassroots divisions (U12 and younger) dribble-in is permitted. A goal cannot be scored directly from the dribble-in before the ball has been touched by another player. The infringement will result in an indirect free kick to the opposing team.
b. In the Grassroots divisions (U12 and younger) heading the ball is not permitted.
i. If a player deliberately plays the ball with their head, an indirect free kick will be awarded to the opposing team. The kick will be taken from the place where the offence occurred.
ii. If the offence occurred inside the player's own penalty area, the ball will be placed at the edge of the penalty area closest to where the offence occurred.
c. NOTE: If the ball makes contact with the ceiling, wiring or a light fixture, an indirect free kick will be awarded to the opposing team of the player that last touched the ball. The kick will be taken from the spot on the field directly below the point of initial contact. (Cf. Rule 9 of the Ontario Rules of Indoor Soccer)
d. Sliding tackles are NOT ALLOWED. This also applies to the goalkeeper. Check Rule 12.
2) For 11v11: International Football Association Board and recognized by FIFA, with particular reference to Ontario Soccer Rules for Outdoor Soccer shall apply, save and except as follows:
a. An indirect free kick shall be awarded should the ball make contact with the ceiling, wiring or a light fixture. The kick will be taken from the spot on the field directly below the point of initial contact.
b. Unlimited substitutions will be permitted on the fly within one (1) metre of the halfway line and the touch line on the team bench side of the field.

## 3. Registration of Players/Coaches

All players must be registered to their respective clubs on the Ontario Soccer's computerized system (OSCAR) and be assigned to their respective divisions.
a) Rosters must be submitted to the league at least seven (7) days prior to the start of the season. Any additions to the rosters must be updated at least 48 hours before the team's game. Any players not added at least 48 hours before a game will not be eligible to play that game.
b) A player must be registered prior to playing in any League, Cup or Playoff game in the Ontario Soccer system (OSCAR). Any player(s)/team official(s) unable to present their duly registered and eligibly stamped Ontario Soccer player book/card electronic ID (System generated roster with pictures) to League staff as required by halftime of each game, will not be allowed to participate in the game. If a player has participated in the game and the book/card/electronic ID has not been presented by halftime, the game WILL NOT proceed, and the team unable to produce the players' ID will default the game with a 3-0 loss and their team/club will be fined according to the Schedule of Fees \& Fines.
c) Coaches must have the proper certifications as per Ontario Soccer requirements:

- Respective Age Stage Certification: Active Start/Fundamentals/Learn to Train/Soccer for Life
- Respect in Sport certification; and
- Making Head Way in Soccer, and
- Making Ethical Decisions Course (inclusive of the Evaluation)
- NCCP Emergency Action Plan
- As a further reminder, the Canada Soccer Grassroots Coach Education (GCE) courses are divided into two distinctive parts - theory and practical - and that all coaches must first complete the theory component of the courses online through Canada Soccer Grassroots Coach Education Academy Platform before registering or attending a practical session.
d) Registration of players will be closed as of the end of February of each playing season for youth teams. As of the last day of February, rosters are frozen, and no changes whatsoever can be made. Any players registered on March $1^{\text {st }}$ and beyond will be ineligible and render all games in which they have participated in to be defaulted 3-0 and may subject the team to being removed from further play in the DSL.
e) Teams may register a maximum number of players as per Ontario Soccer Guidelines (U9 - U12 open roster -12 players game day maximum, U13 - U18 18 players maximum)
f) All rules and regulations as set out in the Ontario Soccer Operational Procedures regarding the signing and registration of players shall apply.
g) The determining factor for age groupings shall be taken from Ontario Operational Procedures, following the year of commencement of the League competition.
i. Notwithstanding f) above, the League reserves the right to group different age groups into one division.
h) A team found guilty of using an ineligible player shall forfeit the game to their opponent, with a 3-0 score being recorded, and may be subject to further disciplinary action at the discretion of the League Committee. A team found guilty of using an ineligible player will subject its club/team to a fine of up to $\$ 500.00$.
i) Players can only play on one team in a division at any given time.
j) Open Rosters (U9-U12): For the U9-U12 Age group teams can play any player in a game that is registered within their club and is of the appropriate age. A player may
only play on one team within that club per week (exceptions must be requested directly from the executive and will be dealt with on a case-by-case basis. Never will a player be permitted to play more than the daily limit as outlined within LTPD standards).
i) The Downsview Soccer League does not permit "Players on Trial", or "Temporary Registration Permits".
j) Teams may register up to 4 "team officials", all of which must also produce a duly stamped Ontario Soccer book/card/electronic ID. Team officials must print and sign their name and provide their Ontario Soccer number on the game sheet.
k) The League Committee shall rule on all disputes regarding player registration, and the Committee's decision will be final.


## 3. Call Ups

Teams U13 and older may use "Call Up" players from their own club (unlimited number of games), under the following conditions:
i. The player is in the same age group or younger, provided their team does not play in the same division.
ii. Notwithstanding i) above, teams in the U13 age division can only call up players from the same age group.
iii. Call ups are not allowed from the U12 or younger age groups.
iv. "Call Up" players must present a current and duly stamped OS book/card/electronic ID in order to be eligible to play.
v. The number of players on a roster and "Call Up" players must not exceed 18 in any game.
vi. Call ups are not permitted in Grassroots divisions U9 to U12.

## 4. Player Transfers

Players are allowed one transfer only during the current playing season. However, a player once transferred cannot be transferred back to the team for which he was originally registered until a period of thirty days has elapsed. The new team the player has transferred to must provide the league with an updated copy of their Ontario Soccer roster with the new player listed prior to them playing their first game with the new team. Club's found guilty of breaking this rule are subject to a fine of up to $\$ 500.00$.

## 5. Playing Season

The playing season shall commence in October and conclude no later than the end of April of the following year (with the exception of unforeseen and/or unavoidable circumstances). Under no circumstances shall the season conclude beyond May $31^{\text {st }}$.

## 6. Discipline

Discipline shall be conducted in accordance with ONTARIO SOCCER policies. The following guidelines apply:
a) Except in cases of ONTARIO SOCCER Misconduct Type 1.3, 1.5 and 1.6, an individual who is subject to the Discipline By Review system (DBR) shall have the right to request a discipline hearing. If the accused person does not request a hearing within 3 days ( 72 hours) of receiving the dismissal (OSA Discipline Procedure 5.3.6.1, 5.3.6.2), the case will be dealt with by DBR and, if the accused person is found guilty, the applicable penalties and/or fines, established by ONTARIO SOCCER for the offence for which they have been charged, shall apply.
b) Any request for a hearing shall be submitted in writing and accompanied with a nonrefundable hearing fee of one hundred dollars (\$100.00) in the form of cheque, money order payable to the North York Soccer Association or Interact e-transfer to nysa@ nysoccer.ca. The request for hearing may be delivered to the DSL office by registered mail, courier service, hand delivered within three days ( 72 hours) of the completion of the game, or email to downsviewsl@nysoccer.ca.
c) Failure by the Referee to provide the game sheets and/or disciplinary reports to the league office within the stipulated time frame does not make the game sheet or any disciplinary reports null and void. The league will process discipline once received and reviewed.
d) In the case of alleged referee assault, discipline shall be handled by the District Association in which the player or team official is registered on behalf of the ONTARIO SOCCER's Discipline Hearing Panel. The accused is automatically suspended from all soccer related activity, as per OS policies and procedures, until the case has been disposed of.
e) Players, clubs, or team officials reported for all general misconduct other than on-field infractions, shall be dealt with as "Special Incident Reports". The accused will be given written notification of the date, time, and location of any proposed hearing. Any person (player or team official) written on a special incident report, shall be suspended until a hearing is held. Failure to appear for a hearing will render the person suspended until a hearing can be held.
g) Any coach, manager, team, or club official ejected from a game, will be subject to (e) above.
h) Players appearing before the Discipline Committee may be accompanied and or represented by a team or club official.
i) Any player, club or team official reported for violent conduct during a match, who is found guilty of such conduct, may be suspended for the remainder of the season.
j) Players, officials, and spectators are allowed to take part in or attend matches on condition that they observe the Constitutions of Ontario Soccer, the North York Soccer Association, the League and its Rules and Regulations.
k) Every club/team is responsible to the League for the actions of its players, team officials and team spectators and is required to take all precautions necessary to prevent spectators from abusing, threatening, poaching, or assaulting officials, players, league, and facility staff. If a team's spectator is found to have been abusing, threatening, poaching, or assaulting officials, players, league and facility staff, the team/club will be subject to a $\$ 500.00$ fine and possible expulsion.

1) No game official, player or official of any club/team shall bet on any soccer match under the jurisdiction of the League.
m) Players and club or team officials suspended from the League shall not take part in any soccer activities in respect to the League, until the completion of the suspension.
(MUST NOT BE ON TEAM BENCH)
n) The League has the right to levy monetary fines against players, teams/clubs, or their officials where it is necessary to maintain a higher degree of control over the game of soccer. Teams or clubs may be required to post bonds for current or future participation.
o) Anyone found guilty and subsequently penalized by the League Discipline Committee has the right to appeal the decision to the appropriate Committee of the North York Soccer Association in accordance with their policies and Procedures on Appeals.

The Downsview Soccer League Committee reserves the right to suspend and expel teams and/or players/team officials that have acted in a manner that may be deemed dangerous to the facility and/or league/facility staff and/or other users. Teams and players on teams instigating and/or participating in fights/brawls may be immediately suspended and/or expelled from further play with no refund of league fees.

## 7. Protests

a) Any protest stemming from a game within the competition must be formally submitted in writing to the League via recorded delivery. This submission should bear the date of submission and must occur within 48 hours following the conclusion of the relevant game. Additionally, a non-refundable protest fee of five hundred dollars (\$500) must be included with the protest submission.
b) In all protest cases, the protesting team is required to send an authentic copy of the submitted protest to the opposing team within 48 hours.
c) A game can only be protested by teams directly involved in the protested game.
d) Protest of a decision by a Referee will not be entertained.
e) The League Committee shall review the protest in the event it has matched the criteria in the above a), b), c), and d). The League Committee's decision will be final.

## 8. General Rules

a) As per Ontario Soccer LTPD guidelines, scores/standings will not be kept for ages U9-U12 inclusive.
b) The players' bench shall be deemed to be an area designated as such by the League. Only the players and team officials registered to that team and entered on the game sheet are allowed on the team bench. Only players who are dressed to play in full uniform are eligible to be on the team bench.
c) Teams must provide each player with identical jerseys with differing numbers on their backs.
d) Teams are only allowed to wear their official club uniforms. Seven days prior to the start of the league, teams are obliged to send in a clear picture of the club's official uniform.
i. Teams are not allowed to play unless the uniform picture is received as above.
ii. If an independent team is playing under a different club, players MUST still wear the club's official uniform.
iii. Teams that play with a different uniform will be charged $\$ 500.00$ (five hundred dollars) and their game will be defaulted.
e) SMALL_SIDED: Under 9-Under 12 inclusive - play 7-a-side (6 and a goalkeeper) SMALL-SIDED: Under 13-Under 18 inclusive - play 6-a-side (5 and a goalkeeper) 11v11: Under 13-Under 18 inclusive - play 11-a-side (10 and a goalkeeper)
f) The goalkeeper must wear a contrasting numbered jersey, which also must be different from the opposing team.
g) The first team named on the schedule shall be the home team. When uniform colours are similar, the home team must change to a distinct colour, or contrasting pinnies. Due to health concerns, the League will not provide contrasting pinnies.
h) Game Duration: Each game shall consist of two equal halves of 25 minutes each. In the event of a delay in the start of a game, the referee may shorten each half to not less than 15 minutes per half. This is subject to the League's approval.
i) A grace period of five (5) minutes will be allowed if a team has less than seven players for 11-a-side play, five players for 7-a-side play and four players for 6-a-side play at the appointed kick-off time, after which the team with not enough players will default the game. The score shall be recorded as a 3-0 score in favour of the opposing team. If both teams have less than the minimum required players, no points will be awarded.
j) Teams forfeiting games will pay $100 \%$ of the game officials' fees and shall be subject to a fine of $\$ 250.00$ to their club/team. A team forfeiting three games could be suspended from further play by the League Committee
k) Player books/cards/electronic ID checks are "Mandatory upon Request" prior to the start of every game (at least 15 minutes before).

1) All players and team officials must have their ID Book/Card/Electronic ID available for presentation to the opposing team official or the League prior to the game.
i. In extenuating circumstances where a team's player(s)/team official(s) book(s)/card(s)/electronic ID is(are) unavailable prior to the beginning of the game, the team will be granted until half time to produce them.
1. In the event the book(s)/card(s)/electronic ID are not produced by this time, the game will not proceed, and the team will forfeit the game as a 3-0 loss to their opponent.
a. If the game proceeds with agreement from both teams, albeit in contravention of this rule, the protesting team waives all rights to protest, and both teams may be subjected to disciplinary action. The final score will the one recorded by the referee.
2. If the game is started and then abandoned at half time because the book(s)/cards(s) was(were) not available, the team/club will be subject to a $\$ 500.00$ fine.
m) Anyone who is unable to produce their ID Book/Card /Electronic ID shall not be allowed to play/coach or sit on the bench.
n) It shall be the responsibility of the team representative to notify the referee of any discrepancies/protests not later than the commencement of the second half of play. The referee must record such discrepancies/protests in their report to the League when submitting their completed Team Sheets.
o) Any teams failing to verify their opponents Registration Books/Cards/Electronic ID will lose all rights of protest on grounds of player/coach eligibility.
p) The team officials are responsible for all players on the team at all times and shall conduct themselves in a manner in accordance with the Rules and Regulations of the League and shall confine themselves to the bench area along with the players. The team official shall only enter the field of play when authorized by a game official.
i. The use of any extraneous equipment, e.g. megaphones, electronic equipment, flashlights, laser beams, etc., that may disrupt the normal course of the game is strictly prohibited and may result in immediate expulsion from the premises and subject the club to a $\$ 1,000.00$ fine.
q) Any game abandoned by a game official will be dealt with by the League/Discipline Committee who shall decide the result of the game, which may include rescheduling the game or a loss for either team.
r) A player or team official impeding, harassing, or otherwise intimidating a game official, opposing team official, opposing player or any facility or league staff, will be subject to severe disciplinary action, including a fine to the club/team of up to $\$ 1,000.00$.
s) Unlimited substitutions are permitted at any time and may be made on the fly (Applies to both 11v11 and Small Sided games). Substitutions do not require a stoppage in play and the game cannot be delayed for carrying out the substitution. All substitutions must take place within one metre of the halfway line on the side of the field where the substituting player's bench is located.
t) All games will be played as scheduled unless:
i. At the discretion of the League, postponement is necessary due to inclement weather or other unavoidable circumstances.
ii. Scheduled games conflict with Ontario Indoor Cup.
u) Postponed games must be played as rescheduled by the League. Failure to comply could result in no points being awarded and penalties/fines imposed. The League reserves the right to give a minimum of one-week notification prior to the rescheduled game date, regardless of whether the rescheduled day differs from the team's regular game day.
v) For applicable divisions, a team shall be awarded three (3) points for a win, and one (1) point for a tie. In the event of a tie in points in the League standings at the end of the regular season, the tie will be broken according to the following:
i. Most Wins.
ii. Highest Goal Differential (Goals For minus Goals Against) throughout the entire regular season.
iii. The team with the most Goals For throughout the entire regular season.
iv. The team with the least goals against throughout the entire 18 regular season.
v. The winner of the head-to-head competition between the two tied teams only (when more than two teams are tied, rule iii (below) applies. If the teams are still tied, they will continue with ii, iii, iv, v and vi if necessary.
vi. A coin toss in the presence of both team representatives and the league.
w) The use of shin guards is mandatory at all ages and levels of play.
x) Outdoor footwear (cleats) is permitted provided the cleats are not metal or dangerous.
y) A size 4 ball will be used for all age divisions up to and including U-12. A size 5 ball will be used for ages U-13 and up. The home team shall provide the game ball.
z) Use of foul and/or abusive language at the Hangar Sport \& Events Centre is strictly prohibited. Any team member found to have been using such language, while on or off the field of play, while on the facility's grounds, will put their team/club at risk of being heavily fined or expelled from further play.
aa) Prior to the game, teams must provide 3 copies of the game sheet computer generated online in E2E Soccer, the league's Management System, with the complete information, i.e., players' shirt numbers, names, and SEOS numbers, along with team officials' names, SEOS numbers and signatures. Handwritten additions are not permitted. Failure to do this may subject the team to a fine and/or disciplinary action. If a player/team official is not taking part in the game, their name should be scratched, as all listed are deemed to have participated in the game.
i. In extenuating circumstances where a proper game sheet cannot be produced, the game must proceed, but the team must provide the referee with a written list of players and team officials.
ii. The team will be assessed a fine as per Appendix A
bb) An Ontario Soccer Official Roster MUST be submitted to the league at the time specified prior to the beginning of the season.
cc) For any additions or deletions from the team roster, the team must supply the league with an Ontario Soccer Official Roster approved by the District 48 hours before the game, clearly showing these changes. Failure to comply with the above will render any added player ineligible and the team be subject to 3 (h) above.
dd) As Per the Ontario Soccer LTPD Policies the U9-U12 leagues will operate with the Retreat Line in effect. The retreat line is at the $1 / 3$ spot on either end of the field. The retreat line will come into play when the ball has gone out for a goal kick or when the goalkeeper has the ball in their possession.

All opponents must be behind the retreat line and cannot cross until the ball:

- Is touched by a player of the team taking the goal kick $\underline{\mathbf{O R}}$
- Leaves the field of play OR
- Goes over the retreat line (If goalkeeper chooses to play the ball across the retreat line prior to the opposition crossing the retreat line)
ee) Within 24 hours after completion of the game, teams must submit a game report on the League's website (Games/Game Report). Failure to do so will result in a fine.


## 9. Cup/Playoff Rules

a) All players must be registered with their club/team by March 1 to play in any cup game or playoff game.
b) In all "knockout" rounds of the cup/playoff, if the game is tied at the end of regulation time, then penalty kicks shall be taken per the following guidelines:
i. All players listed on the game sheet are eligible to take part in the taking of penalty kicks. In the event a team has more players on the bench than the other, the referee will ensure that the numbers are even before the taking of the kicks. All players taking part in the kicks must remain in the centre circle.
ii. Any three players on the team may participate in the taking of penalty kicks.
iii. The goalkeepers at the time of the end of regulation time must be the goalkeepers for the respective teams during the penalty kicks.
iv. In the event both teams are tied after 3 kicks, penalty kicks will resume into "sudden death". All players listed on the game sheet must shoot once before another player may shoot a second time (unless a player sustains an injury which prevents the players from participating. In this case no need to even the number of penalty takers).
v. Player's shin-guards must remain in place at the time of penalty kicks.
c) All forfeited games will be recorded as a 3-0 Default win.

## 10. Administrative

a) Absolutely no changes to the final schedules will be entertained. Reschedules will only be as per $8(\mathrm{t})$.
b) Any complaints (other than protests), about Referees and/or game outcomes must be put in writing and submitted to the League office (downsviewsl@ nysoccer.ca). The results of the game will not be changed. Only legitimate complaints will be entertained. No verbal complaints will be entertained; if a team member is found to have been venting during or after the game about the referee, the complaint, when then put into writing, will not be heard.
c) Only the League Committee is empowered to deal with complaints, which must be made as per (b) above. Only the League Committee can determine which complaints are frivolous and which complaints are genuine. The committee's decision is final.
d) All fines are due and payable prior to the next scheduled game. Failure to remit payment on time could render the team/club suspended from further League participation until payment is received by the League. Games scheduled during such a period of suspension will be considered forfeited and applicable Rules and Regulations will take effect.

## 10. Other Matters

a) All matters not included in these Rules and Regulations shall be judged in accordance with the Constitution and By Laws of the North York Soccer Association and/or the Ontario Soccer.

## 11. Facility

The Hangar Sport \& Events Centre and the Hangar Dome are drug, tobacco, and alcohol-free facilities. Consumption is strictly prohibited. Any violation of any published rules and regulations will result in severe monetary fines and penalties as well as suspension and possible banning from The Hangar.

## Appendix "C"

## READ CAREFULLY - DISCIPLINE ADVISORY NOTICE

Teams who have Disciplinary action taken against them by their assigned Referee will be penalized in accordance with the Downsview Soccer League Rules and Regulations and be subject to a fine to be determined by the League Discipline Committee.

The Discipline Committee adjudicating shall consist of at least a chairperson and two (2) other members. Where it is necessary to maintain a higher degree of control over the game of soccer, The Downsview Soccer League reserves the right to levy monetary fines against teams/clubs or their officials.

The individual who receives the Red card must leave the field of play including the team bench and viewing area immediately. All individuals receiving a Red card will automatically miss their next game and will receive further disciplinary action and/or fines in line with and according to the severity of their offence and actions. This can range from the minimum to the maximum suspension and fine.

Players/team officials or teams have the option of requesting a Discipline by Hearing. All such requests must be submitted in writing within 72 hours of the date of the game in which the Dismissal occurred. The request must be accompanied by the non-refundable Hearing Fee of $\$ 100.00$. In all cases, if no request is received, a discipline by Review process will begin by the league Discipline Committee. All Players appearing before the Discipline Committee may be accompanied and or represented by a team or club official. Anyone found guilty and subsequently penalized by the League Discipline Committee via D.B.H process, has the right to appeal the decision to the appropriate Committee of the North York Soccer Association in accordance with their policies and Procedures on Appeals. Disciplines by Review decisions are final and cannot be appealed.

In cases of alleged assault of a game official, by a player, team or team official, the accused party shall be suspended immediately from all soccer activity until the assault charges have been heard and adjudicated by the Discipline Committee of the Relevant Soccer Association, as per the Ontario Soccer Constitution. The Downsview Soccer League reserves the right to expel any person, player, club, or team official found guilty of assault indefinitely from participating in any activity at the Hangar.

ANY COACH, MANAGER, TEAM, OR CLUB OFFICIAL BEING DISMISSED FROM THE FIELD OF PLAY BY THE REFEREE OR CONVENER DURING A GAME, WILL BE SUBJECT TO THE ABOVE-MENTIONED PROCESS AND MUST ATTEND A HEARING AT THE LEAGUE'S REQUEST.

Any Player or team official reported for violent conduct during a match, who is found guilty of such conduct, may be suspended for the remainder of the season as indicated in The Downsview Soccer League Rules and Regulations. (Players and team officials under suspension shall not take part in any soccer activities at the Hangar for the duration of the suspension.
